

## Estimated Fees & Costs for Surrogacy

This is intended to be an example of the typical costs of Surrogacy. There are many variables in each Surrogacy cycle, and we are happy to provide a close estimate based on your circumstances.

### \* **My Donor Connection Agency Fee** **\$20,500**

The Agency Fee includes the following services: Clinic Selection, Match with Pre-Qualified Surrogate, Background Checks, Review of Insurance, Coordination with Legal and Medical Professionals and Trust Account Facilitation with MDC

**First Payment due upon Surrogate Selection and Signed Agency Agreements \$7,000**

**Second Payment due upon Medical and Legal Clearance \$7,000**

**Final Payment due upon Confirmation of Pregnancy \$6,500**

### \* **Surrogate Compensation** **\$35,000**

Reminder: This is only an example of what to expect with your Surrogate Compensation. Your contract with your Surrogate will detail all appropriate fees and allowances

**Surrogate Compensation \$30,000** estimate only- compensation will be listed on Surrogate profile

**Monthly Cycle Allowance \$2,400** - This allowance is in lieu of itemized reimbursements. This covers expenses related to mileage reimbursements, co-pays, child care for appointments, vitamins & prescriptions. \$200 per month paid for approximately 12 months (or as detailed in your contract)

**Mock Cycle \$250** paid at the conclusion of each Mock Cycle

**Embryo Transfer \$750** paid at the conclusion of each Embryo Transfer

**Maternity Clothes Allowance \$500- \$750** Paid at the start of the second trimester.  
\$500 for singleton/ \$750 for multiples



### Clinic Expenses

### Legal Fees

**\$4,500- \$8,500**

Legal Fees are paid directly to your and the Surrogates Legal Counsel. The Fees below are estimates only. It is imperative that either you or the Surrogates Representation is licensed in the state that the Surrogate will deliver. We are happy to make a referral for both you and the Surrogate. Pre Birth Orders/ Parentage Proceedings should also be handled by an attorney that is licensed in the state your Surrogate will deliver.

Intended Parent Legal Counsel: Legal Contract with Surrogate \$1,500 - \$2,500

Surrogate Legal Representation - Contract Review \$500- \$1,000

Pre Birth Order/ Parentage Proceedings / P0st Birth Parental Establishment  
\$2,500- \$5,000



### Possible Additional Compensation

Reminder: This is to give you an idea of additional expenses that could arise. These items will be addressed in your legal contract and can be negotiated to amounts you feel appropriate

**Multiple Fee \$5,000**

**Invasive Procedures \$750**

**Cesarean Section \$1,500**

**Loss of Reproductive Capabilities \$2,500**

**Bed Rest Benefits** If the surrogate is placed on bed rest, this amount could cover lost wages, child care & housekeeping

**Insurance:** If the Surrogate does not have medical insurance or life insurance, the intended parents would have to purchase a policy. It is not uncommon to purchase a backup or additional policy in addition to the insurance already in place

**Travel \$3,000** Estimated Travel includes airfare for Surrogate & Companion (if needed) hotel, ground transportation, meal per diem

**Local Monitoring \$2,500** Local Monitoring Appointments: Blood work and Ultrasounds
